### **77. PARKS IN KNOWSLEY**

Councillor Morgan, the new leader of Knowsley Council, gave a presentation to explain the abandonment of the parks trust scheme, following a backlash from the public. This was a result of a poor consultation with those affected by park closures. The Council was running a deficit and this had worsened the situation. Council officers will be visiting us to discuss the implications for us, if any.

### **78. PUBLIC PARTICIPATION**

There was a complaint made by residents about disturbance in the Pasture caused by overspill from a party of young people at the Holy Family Social Club on Saturday 13 October. The Police were called to deal with this. Councillor Morgan mentioned that he would put the Council in touch with an anti-social behaviour council/police group.
